### **ACCIDENT WAIVER AND RELEASE OF LIABILITY**

I acknowledge that this athletic event is an extreme test of a person's physical and mental limits and carries with it a potential for death, serious injury and property loss. The risks include, but not limited to, those caused by terrain, facilities, temperature, weather, condition of athletes, equipment, vehicular traffic, actions of the people including, but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event, and lack of hydration. These risks are not only inherent to athletics, but are also present for volunteers. I hereby assume all the risks in participating and/or volunteering in this event. I realize the liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently trained for participation in the event and have not been advised otherwise by a qualified medical professional. I acknowledge that this is an Accident Waiver and Release of Liability form will be used by the event holders, sponsors, and organizers, in which I may participate and that will govern my actions and responsibilities at said events. In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability from my death, disability, personal injury, property damage, property theft, or actions of any kind which my hereafter accrue to me including my traveling to and from this event, THE FOLLOWING ENTITIES FOR PERSONS: Their directors, officers, employees, subcontractors, volunteers, representatives and agents, the event holders, event sponsors, event volunteers: (B) Indemnify and Hold Harmless the entities of persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this event, whether caused by negligence of releases or otherwise. I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident, and/or illness during event. I understand that at this event and related activities, I may be photographed, I agree to allow my photo, video, or film, likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers and assigns.
